1. Biswanath Chariali, (in the premises of the erstwhile Biswanath Mahkuma Parishad in Sonitpur district).
2. Abhayapuri (in the premises of erstwhile North Salmara Mahkuma Parishad in Bongaigaon district).
3. Saraighat (in the campus of Bezera Dev. Block in Kamrup district).

The functional jurisdiction of all the 8 Extension Centres is demarketed as follows to cater to the local needs on Training & Technology Development support services.

6. Sariahtoli, Nalbari	Nalbari, Barpeta.
7. Abhayapuri, Bongaigaon	Dhubri, Bongaigaon, Goalpara, Kokrajhar.
8. Saraighat, Bezera	Kamrup (North part), Darrang.

The main functions of the centres are as follows :

1. To organise training programmes for officials, non-officials, elected representatives of PRIs, NGOs and CBOs on planning and implementation of various programmes of Rural Development.
2. To conduct Seminar and Workshop on Education, Health, Sanitation, Drinking Water, Equity, Social Justice, Law, Social problems etc. for officials, non-officials and NGOs.
3. Development and Nurturing of SHGs.
4. Technology transfer to rural areas through skill development training, adoption and adaptation.
5. Technology display, demonstration, dissemination and modernisation.

The Extension Centres will function under the Administrative control of SIRD, Assam.
